Services:

Kindred Mother Care LLC, agrees to provide in-home postpartum doula services to and

Services include emotional support, help with infant care, lactation and breastfeeding help, tips on infant feeding and helping with the household work as needed, so that the mother can rest, recover, and better care for her newborn and herself.

Schedule:

Services will begin on _____ .Kindred Mother Care, LLC and client can then chose to extend the contract as needed, depending upon availability.

_____ Client agrees to pay the doula for time and groceries needed to prepare meals.

_____ Any extensions or changes in the contract must be discussed directly with Sejal Fichadia, of Kindred Mother Care, LLC.

Errands:

You can ask your doula to stop at the store and pick things up for you on her way to your home. In this case, the doula should be reimbursed for any expenses on the same day, and the time for her shift will begin when she arrives at the store.

_____ Your doula cannot drive you or your children but can ride with you to an appointment.

_____ You cannot leave the doula with your child/children by herself because that is beyond her scope of practice.

Payment/Refund:

Client agrees to pay _____ (hourly) for daytime work and _____ (hourly) for nighttime doula work.

Kindred Mother Care requires that you sign up for at least four hours of postpartum care per day.

A \$160 deposit, which will be applied to the **last 2 weeks** of service, is due with this contract.

If the client should decide not to use Kindred Mother Care LLC's services, we will refund all but \$160 of the deposit.

A decision to cancel less than 5 days before the start date will result in forfeiture of the deposit. Checks can be made out to Kindred Mother Care, LLC, and sent to the above address. You can also choose to PAYPAL the money to zobars@yahoo.com.

Payment in full will be due at the end of each week and there will be no refunds or reductions in hourly rates after the signing of this contract by the client, unless specifically approved by Sejal Fichadia *prior* to the end of doula service.
